The report aims to track investment patterns as they prevail in accordance to the trading activities associated with the various nationality groups active in ASE.

Net Investment in ASE as per the end of September 2017:

Jordanian Investors were Net Sellers

Jordanian investors bought ASE shares valued at JD76.46 million, while selling JD75.35 million. Thus, resulting in a positive investment of JD 1.14 million (Compared to a negative investment valued at JD5.94 million recorded during August 2017)

As for Arab Investors, they have sold shares amounting to JD7.33 million, opposed to buying JD7.37 million of ASE shares. Thus, resulting in a positive investment of JD32.93 thousand. [Compared to a positive investment valued at JD18.05 million recorded during August 2017]

Finally, Foreign investors sold shares worth JD5.43 million, and have bought JD4.29 million of ASE shares. Thus, resulting in a negative investment of JD1.29 million. (Compared to a negative investment valued at JD12.11 million shown during August 2017)

ASE Ownership & Trading - According to Nationality

ASE Nationality classification is associated with the main three investor categories; namely, Jordanians, Arabs and Foreigners. As such, Jordanian investors hold a little over 54% of ASE's total market cap, while Arab investors contribute to almost 35% of ASE's total market cap, leaving foreign investors with a share of almost 10% valued at JD 1.85 billion.

With reference to the top ASE nationalities according to ownership, the Qatari ownership in ASE ranked second after Jordanians, owning 6.14%, while Kuwaiti ownership came in third place with an ownership of 6.01% of ASE market value.

After examining the number of transactions executed during this month, it was found that Jordanian investors were the most active as they have executed 92.09% of all transactions, which left the Palestinian traders with a minor share of 3.31% and Americans with that equal to 1.83%.

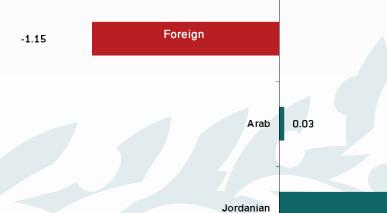

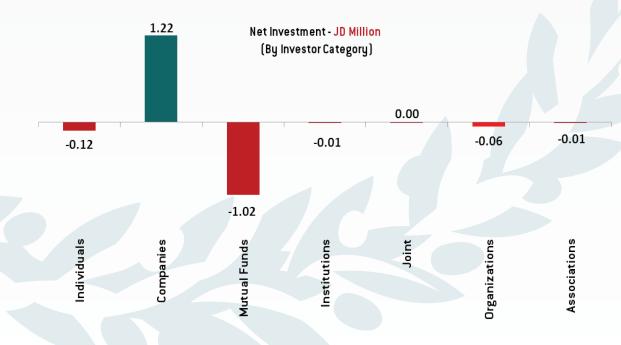

51.01% of the Banking Sector securities are in the hands of Jordanians, valued at JD4.10 billion.

69.19% of the Insurance Sector securities are in the hands of Jordanians, valued at JD220.04 million.

80.73% of the Services Sector securities are in the hands of Jordanians, valued at JD3.64 billion.

65.62% of the Industrial Sector securities are in the hands of Jordanians, valued at JD1.51 billion.

In other words, 66.58% of 253 listed companies securities on the ASE are in the hands of Jordanians, while Arabs and Foreigners own 26.55% and 6.88% of ASE securities, respectively.
